HDA Antitrust Policy

- It is the unqualified policy of HDA and all of its operating committees to conduct their operations in strict compliance with the antitrust laws of the United States.
- HDA's antitrust policy prohibits any discussions which constitute or imply an agreement or understanding concerning: 1) prices, discounts, or terms or conditions of sale; 2) profits, or profit margins or cost data; 3) market shares, sales territories or markets; 4) allocation of customers or territories; 5) selection, rejection or termination of customers or suppliers; 6) restricting the territory or markets in which a company may resell products; 7) restricting the customers to whom a company may sell; or 8) any matter which is inconsistent with the proposition that each member company of HDA must exercise its independent business judgment in pricing its services or products, dealing with its customers and suppliers and choosing the markets in which it will compete.







Exceptions Management Process

- Enhanced Supply Chain Security requirement
 - Identify exceptions
 - Notify trading partners
 - Resolve exceptions (3 days)





Problems

- Failed EPCIS data exchange leads to supply chain interruptions.
- Unresolved exceptions causing delays or non-receipt of products.
- Shipments associated with unresolved exceptions are returned to senders, leading to inefficiencies and waste.

Risks

- Increased workload for both sender and receiver
- Creating inventory shortage, back order, and risk of lost business
- delays in revenue recognition, lost revenue, and increased reverse logistics




LSPedia Exceptions Pilot Takeaways

- LSPedia Exceptions Pilot from Jan. 2023 to May 2023
- Best time to catch exceptions is in the EPCIS data file itself
- Send best time is at receiving
- After receiving, Rx/Data mismatch becomes difficult to sort out



Common Exceptions

Validate EPCIS



Rule based alerts to sender/receiver

- Syntax Errors
 - Malformed XML, whitespaces
- Semantical errors
 - Chronology issues (timestamp)
- Older versions
 - EPCIS 1.0, EPCIS 1.1
- Missing master data
 - GTINs, GLNs
- Missing key business data
 - PO
 - Aggregation events
- Late files, duplicate files...






